ELIGIBILITY

Eligibility for the competition extends to law students currently pursuing their Bachelor's degree in Law, i.e., 3-year LL.B. or 5 Year LL.B. Programme.

TEAM COMPOSITION

Each team shall consist of 3 members. Each team shall include two orators (speakers), who will be accompanied by one researcher, all of whom must be designated accordingly during the registration process. Each team will be allotted a team code. The team code will be sent to the teams via email after registration is complete. Teams shall not disclose their identity of their institution or city at any time during the competition; such disclosure shall invite penalties, including disqualification. The decision for the same shall be at the discretion of the organizers.

REGISTRATION PROCEDURE

Early Bird Registration for the Moot Court Competition Rs. 2000 /- (Rupees Two Thousand only) without accommodation and Rs. 4000 /- (Rupees Four Thousand only) with accommodation (On or before 25th September, 2025; 11:59 PM)

The Participating team shall duly fill the Registration Form provided along with the official rules and send it along with a Registration fee of Rs. 3000 /- (Rupees Three Thousand only) without accommodation and Rs. 5000 /- (Rupees Five Thousand only) with accommodation. The Registration fee shall be sent through Online Payment.

The last date for receiving the registration form with the fee shall be 31st October, 2025. The participants are required to submit two passport-sized photograph of each team member at the time of on-desk registration.



Each team shall be allotted a Team Code after sharing the receipt of the registration fee and form via email, mootcourtsociety@quantumeducation.in.

The Draw of Lots for the preliminary rounds will be conducted on the morning of 14th November, 2025, by the participating team members. The name of the Institution shall not be disclosed at the time of submission of memorials. Any such disclosure shall lead to disqualification.

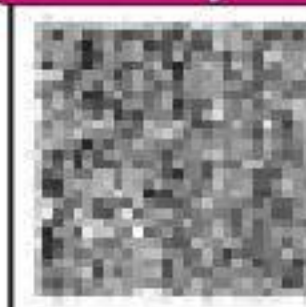

RULES OF THE COMPETITION

- ❖ The language of the competition shall be English.
- ❖ All participants shall maintain decorum in the court during the competition and are expected to conduct themselves in a manner befitting the legal profession
- ❖ Audio or Video taping of oral proceedings is NOT PERMITTED
- ❖ If a Team believes that a violation of the Competition Rules has taken place at any stage of the Competition, the Team(s), within half an hour after the completion of the round in which the violation has allegedly occurred, should register a complaint with the committee on mail, mootcourtsociety@quantumeducation.in teams under no circumstances shall approach the Panel with any complaints.
- ❖ Teams shall not use phones, the internet, or any other devices during the rounds for anything except participating in the rounds.

SAVING CLAUSE :

- ❖ The Organizing Committee reserves the right to add, vary, amend, or modify the Rules at any point in time.
- ❖ In case of any ambiguity or differences arising as to the interpretation of Rules, the interpretation approved by the Organizing Committee will be final
- ❖ In case the Rules are silent on any aspect of the Competition, the Organizing Committee may issue instructions or directions to manage the void

MEMORANDUM OF WRITTEN SUBMISSIONS

The following requirements must be strictly followed with respect to the submission of the Memorandum of Written Submissions. Non-conformities will be liable to penalties while awarding marks thereon.

- a. Each team must prepare a Memorandum of Written Submissions for both sides to the dispute (Petitioner and Respondent). The cover page of the memorials for the Petitioner shall be in **Blue**, and the Respondent shall be in **Red**.
- b. Once the Memorandum of Written Submissions has been submitted, no revisions, supplements, or additions will be allowed; however, teams may carry annexures along with them and can submit them at the beginning of each round.
- c. Teams shall send a soft-copy of the Memorandum of Written Submissions in Adobe PDF format only, mootcourtsociety@quantumeducation.in on or before 8th November, 2025.
- d. All participating teams shall submit 06 sets of written memorials (Six sets, i.e., 6 for Petitioner and 6 for Respondent - total 12 copies) must reach the organizers at the time of accommodation. Participants are advised to carry copies of the Memorandum of Written Submissions during the competition for their own perusal.
- e. Any revisions, supplements, or additions to the Memorandum of Written Submissions after submission shall not be allowed.
- f. Written memorials shall be printed on white A4-size paper with black ink and neatly bound. No plastic divider should be used in the memorials. The font of the body of the Memorial must be Times New Roman, size 12, with 1.5 line spacing, and the font size of footnotes, if any, must not be less than size 10.
- g. Blue Book mode of citation (20th Edition) must be followed. Each page must have a margin of at least an inch on all sides. The Memorial should not exceed 40 typed pages (not including the Cover Page) and shall consist of the following parts :

STRUCTURE OF ROUNDS

❖ Preliminary Rounds

There shall be two preliminary rounds, and every team shall be allowed to argue on each side. The Draw of Lots for the Preliminary rounds shall be drawn by the Committee on 14th November, 2025. Each team will have a total of 30 minutes to present their case. This time also includes 'rebuttal' and 'sur-rebuttal'. The opportunity for a rebuttal is at the discretion of the judges. Any extension of time beyond the specified period shall be subject to the discretion of the judges. The division of time between the speakers is the discretion of the team members, subject to a maximum of 20 minutes for one speaker. Before the commencement of each round, each team shall indicate to the Court officer how they wish to allocate their time. At the end of the preliminary rounds, **the top 8 teams will qualify for the Quarter Finals**. The top teams will be selected on the basis of scores. For calculation, the marks awarded for the oral round will be evaluated for 200 Marks in the round. In case of a tie, the teams shall advance to the next round on the basis of the highest memorial score. If the tie is still not broken, then the highest speaker score will determine which team advances to the Quarter-finals.

❖ Quarter-Finals

The Quarter Finals will be held after the completion of the preliminary rounds, i.e., on 15th November 2025. The Quarter Finals shall be a knock-out round. A team will be credited with a win in the Quarter Finals if their total marks are higher than their opponent's. The side to be presented by the team shall be determined by way of a draw of lots, with the teams picking the lots after the completion of the preliminary rounds. Each team will have a total of 30 minutes to present their case. This time also includes 'rebuttal' and 'sur-rebuttal'. The opportunity for a rebuttal is at the discretion of the judges. The division of time between the speakers is the discretion of the team members, subject to a maximum of 20 minutes for one speaker. Before the commencement of the



round, the qualifying team shall indicate to the court officer their wish to allocate their time. The winners of the Quarter-final round will be determined using the knockout method. In case of a tie, memorial scores will be considered to determine the semi-finalist. Four teams shall advance to the semi-final round.

❖ SEMI-FINALS

The Semi-Finals will be held on 15th November 2025. The Semi-Finals shall be a knock-out round. A team will be credited with a win in the Semi-Finals if their total marks are higher than their opponent's. The side to be presented by the team shall be determined by way of a draw of lots, with the teams picking the lots after the completion of the quarter-final rounds. Each team shall get a total of 40 minutes to present their case. This time also includes 'rebuttal' and 'sur-rebuttal'. The opportunity for a rebuttal is at the discretion of the judges. The division of time between the speakers is the discretion of the team members, subject to a maximum of 25 minutes for one speaker. Before the commencement of the round, the qualifying team shall indicate to the court officer their wish to allocate their time. The winners of the Semi-final round will be determined using the knockout method. In case of a tie, memorial scores will be considered to determine the finalists. Two teams shall advance to the final round.

❖ FINAL ROUND

The final round will be held on 16th November 2025. A team will be credited with winning the Final if their total marks are higher than those of their opponent team. Each team shall get a total of 45 minutes to present their case. This time also includes 'rebuttal' and 'sur-rebuttal'. The opportunity for a rebuttal is at the discretion of the judges. The division of time between the speakers is at the discretion of the members, subject to a maximum of 30 minutes for one speaker. Upon commencement of the round, the qualifying team shall indicate to the court officer their wish to allocate their time. In determining the winners in the Final round of the competition, the team that has secured the highest marks in the oral presentation shall be considered.

EVALUATION CRITERIA FOR ORAL PLEADING SESSION

The oral Pleadings would be marked on a scale of 100 marks per judge and would be evaluated on the following grounds :

SCOUTING

1. Teams will not be allowed to observe the orals of any other team. Scouting is strictly prohibited. Scouting by any team member will result in immediate disqualification. The organizer's decision will be final in this regard.
2. The researchers shall sit with the orators at the time of the orals and shall not attend the court sessions of any other team participating in the competition.



RESEARCHER TEST

The Researcher Test shall be conducted on Day 1, i.e., 14th November 2025.

1. The test shall be for a duration of thirty (30) minutes only. The test will be based on MCQs (Multiple Choice Questions) of Sixty Marks, 30 questions.
2. If a team comprises three (3) members, then ONLY the Researcher is eligible to take the test. Researcher test marks will NOT be added up in the marking criteria.
3. In the situation of a tie, the memorial scores shall be added, and the team with the higher total will be declared the winner.

ANNOUNCEMENT OF RESULT

1. The results of the Preliminary rounds, Quarter-final and Semi-final rounds shall be announced shortly after the completion of the rounds.
2. The winners of the competition will be announced during the valedictory ceremony on 16th November, 2025.

DRESS CODE

The official Dress Code for the Competition is as follows:

Robes are not permitted.

Gentlemen: Black Trousers, White Shirt, Black Blazer, Black neck tie, and Black formal shoes;

Ladies : Black Trousers/Skirt, White Shirt, Black Blazer, Black neck tie, and Black formal shoes (or) White Salwar Kameez, Black Blazer, and Black Formal shoes.

QUERIES / DISPUTES

In all matters of complaints or disputes, the decision of the Committee shall be final.

ACCOMMODATION

Participants from outstations shall be provided with shared accommodation by the university for the duration of the competition. Only the registered members of the team shall be provided with accommodation. The team shall make their own arrangements for any extra members. All teams shall be provided with accommodation from noon of 13th November, 2025, till the morning of the 17th November, 2025.

MOOT PROPOSITION

BACKGROUND

1. In recent years, Dharamrashtra has witnessed a significant surge in the development and adoption of Artificial Intelligence (AI) tools, particularly within the fields of entertainment and creativity. **Connect AI**, a technology enterprise that has received partial financial assistance under government-sponsored projects and operates under oversight and strategic guidance from the Ministry of Technology, launched an advanced AI platform in December 2023 under the name **Gen Create**. The funding was extended to Connect AI in furtherance of public interest objectives, including the promotion of indigenous AI research, technological innovation, and the development of scalable digital solutions for societal benefit.
2. Acclaimed as a game changer in Dharamrashtra's digital creator economy, Gen Create allows users to generate hyper-realistic digital content, including videos, avatars, voiceovers, and animations, by simply uploading basic media such as images, audio clips, or text prompts. Its core engine is built on large-scale machine learning models trained using publicly accessible data, scraped from social media, YouTube, interviews, films, and public events.
3. By February 2024, Gen Create became very popular with more than 30 million users, and the enterprise had also partnered with several regional advertising agencies and digital influencers. Connect AI's Terms of Use allow the platform to process, store, and reuse user-uploaded data for its development and marketing purposes, while disclaiming liability for any misuse of the tool by users.
4. In March 2024, several videos created using Gen Create began circulating across Dharamrashtra social media. These videos featured **Raj Malhotra**, a renowned actor known for his commanding screen presence and iconic voice. The AI-generated videos portrayed Raj endorsing a wide range of products, from beauty creams and cryptocurrency apps to political slogans and inappropriate opinion pieces.
5. One widely shared video showed Raj appearing to support a candidate in a state election, while another depicted him making disrespectful comments about other actors, remarks he had never actually made. Although fake, the videos looked and sounded real, perfectly copying Raj's voice and expressions. Notably, Raj had never given consent for any such use of his identity or voice.
6. These videos quickly gained millions of views and were further amplified through paid promotions, influencer reposts, and even embedded advertising by third-party vendors. Despite not having participated in or authorized the creation of such content, Raj's apparent presence in these videos misled the public into believing they were genuine endorsements.
7. Soon, fans, journalists, and even government officials began reacting to these clips as if they were real. Several brands that had signed endorsement deals with Raj expressed concern over breach of exclusivity and reputational harm. Public discourse spiraled into confusion, misinformation, and online abuse.
8. In response to the criticism, Connect AI released a broad statement claiming that it merely provides the AI tools and has no control over the content users create. The enterprise further emphasized that it already follows community guidelines, has systems to report objectionable content, and maintains data protection practices in line with current technology standards.
9. The controversy quickly snowballed into a debate on the limits of AI innovation, the need for digital persona protection, and the lack of a legal framework to regulate the



use of **synthetic media**. Multiple actors, cricketers, and even news anchors reported similar unauthorized simulations.

10. The platform did not take any independent measures to remove the disputed videos and acted only upon formal reporting. Observers contended that since Connect AI had **created** a tool by which it gained a significant number of users, and it enabled the impersonation of real individuals, it could not merely evade responsibility by stating that it had followed all the standards, guidelines, and had a reporting system.
11. In April 2024, a young student from Malvik was expelled from school after sharing a video of a well-known school principal seemingly making inappropriate remarks. The video was later revealed to be AI-generated through Gen Create. Around the same time, a fake video of a former Union Minister endorsing a banned investment scheme circulated widely, causing panic and financial loss to thousands of people in rural districts.
12. While law enforcement agencies attempted to respond, they found themselves operating in a legal vacuum, as existing laws did not clearly define synthetic identity misuse, **AI-generated deception**, or a platform's accountability for algorithmic content.
13. Meanwhile, civil society groups began mobilizing. **The Citizens for Digital Rights Forum (CDRF)**, a non-profit organization based in Delhica, on May 15, 2024, filed a Public Interest Litigation (PIL) before the Supreme Court of Dharamrashtra against the Ministry of Technology, making Connect AI also a party. The PIL was filed on behalf of all affected persons, including public figures, professionals, and ordinary citizens, who had suffered due to unauthorized AI-generated impersonating content.
14. The PIL highlighted that the absence of clear legal protections has led to the misuse of AI in ways that threaten democracy, consumer safety, personality rights, and individual dignity.
15. The filing coincided with parallel developments:
 - i) The Ministry of Technology issued a consultation paper in April 2024 proposing a regulatory framework for AI, but critics said it lacked urgency.
 - ii) A Parliamentary Standing Committee on IT was conducting hearings on AI and misinformation, but its recommendations were still months away.
 - iii) Several industry bodies warned that excessive regulation could harm Dharamrashtra's booming AI ecosystem in gaming, animation, and education.
16. The case has since become a test of how Dharamrashtra's constitutional law, technology law, and free speech jurisprudence adapt to the challenges posed by AI-driven synthetic media. It is also expected to shape the future of Dharamrashtra's digital economy, balancing innovation with accountability



ISSUES FOR CONSIDERATION BY THE SUPREME COURT

1. Whether the creation and circulation of AI-generated content simulating a person's identity without consent infringes the fundamental right of privacy under Article 21 of the Constitution.
2. Whether AI-generated impersonation of public figures for commercial, political, or humorous purposes can be protected as creative expression, or whether it must be subject to the appropriate limitations to uphold societal values and safeguard individual rights.
3. Whether platforms that develop and commercialize generative AI tools bear legal and ethical responsibility for how these tools are used, and if so, to what extent.
4. Whether the use of publicly available personal data, including facial likeness and voice, for training and deploying generative AI tools without explicit consent violates the norms of the digital personal data protection.
